

A certification system that indicates products and services comply with Islamic law (Sharia). An international standard guaranteeing Muslims can use them with peace of mind.




## 🐴 Sharia Compliance

A regulatory framework that ensures financial transactions, products, and services adhere to Islamic law.

- Prohibition of Interest (Riba) Forbids receiving or paying interest on loans
- Avoidance of Speculative Transactions Restricts transactions with uncertainty
- Clear Value Backing Emphasizes stability through connection with real assets

AGF is designed according to these Sharia compliance principles, providing stability through gold asset backing.





#### Nyanmaru Mall Integration


Can be used in various use cases including Nyanmaru Mall. Acts as a bridge to convert digital assets into actual purchasing experiences

Exchange design compliant with Islamic law. Avoids Riba (interest) and conducts only transactions backed by real assets






